ABSTRACT

A NEW ERA OF OWNERSHIP AND COMMUNITY IN GAMING


\$CTC (CRYPTO THROUGH COMMUNITY) IS A DECENTRALIZED GAMING ECOSYSTEM THAT MERGES TRUE OWNERSHIP WITH A COMMUNITY-DRIVEN ECONOMY. PLAYERS CAN OWN, EVOLVE, AND TRADE THEIR IN-GAME ASSETS, WHICH ARE LINKED TO NFC-ENABLED PHYSICAL COLLECTIBLES. THE PROJECT INTRODUCES THREE DISTINCT TYPES OF NFTs:

- 6,666 OG CRYPTS, WHICH ARE ART-BASED BOOSTER CARDS EARNING DEADPOINTS FOR HOLDING,
- 6,666 CRYPT TRADING CARDS, WHICH ARE FOCUSED ON GAMEPLAY MECHANICS AND REWARDING VIA PLAYING.
- 3D NFTs, LAUNCHING IN 2025, WHICH WILL INTEGRATE FURTHER INTO THE GAME AS SPECIALIZED ASSETS FOR ENHANCING GAMEPLAY AND PERSONALIZING CHARACTERS.

\$CTC LEVERAGES FRACTIONAL SPENDING, DYNAMIC TOKEN SCARCITY, AND A SEAMLESS WEB2 ONBOARDING PROCESS TO INTEGRATE BLOCKCHAIN TECHNOLOGY WITH TRADITIONAL GAMING, ALL WHILE MAINTAINING A DECENTRALIZED GOVERNANCE STRUCTURE.

2. EXECUTIVE SUMMARY

\$CTC OFFERS A GROUNDBREAKING APPROACH TO TRUE DIGITAL ASSET OWNERSHIP IN THE GAMING INDUSTRY, BLENDING BLOCKCHAIN TECHNOLOGY WITH REAL-WORLD UTILITY. THE ECOSYSTEM REVOLVES AROUND THREE FINITE AND UNIQUE NFT COLLECTIONS



THE 6,666 OG CRYPTS, WHICH ARE ART-BASED BOOSTER CARDS THAT GENERATE DEADPOINTS THROUGH HOLDING 6,666 CRYPT TRADING CARDS, WHICH ARE CENTERED AROUND IN-GAME PROGRESSION AND REWARDS. THESE NFTS EVOLVE AND GAIN VALUE OVER TIME, CREATING AN ENGAGING AND PROFITABLE EXPERIENCE FOR PLAYERS.

WITH FRACTIONAL TOKEN SPENDING AND DYNAMIC BURN MECHANISMS, \$CTC ENSURES LONG-TERM SCARCITY AND ACCESSIBILITY. THE GAME'S GOVERNANCE SYSTEM, DRIVEN BY FACTIONS AND LEGENDARY SKULLS AND TEN GODS, GIVES EVERY PLAYER A SAY IN SHAPING THE FUTURE OF THE ECOSYSTEM.

3. INTRODUCTION: VISION AND PURPOSE

\$CTC WAS FOUNDED ON THE PRINCIPLE OF TRUE OWNERSHIP, EMPOWERING PLAYERS TO OWN, TRADE, AND EVOLVE THEIR IN-GAME ASSETS WITH REAL-WORLD VALUE.

THE GAME CURRENTLY FEATURES TWO KEY NFT COLLECTIONS: THE OG CRYPTS, WHICH SERVE AS ART-BASED BOOSTER CARDS, AND THE CRYPT TRADING CARDS, WHICH ARE DESIGNED FOR GAMEPLAY AND REWARDS.

THE OG CRYPTS ARE TIED TO THE FOUNDER'S LIFE STORY, ADDING A DEEPLY PERSONAL NARRATIVE TO THE PROJECT. EACH TRAIT IS A PERSONAL STORY THE PROJECT IS A LEGACY TO HIS DAUGHTER

\$CTC'S FRACTIONAL SPENDING MODEL ENSURES ACCESSIBILITY TO ALL PLAYERS, REGARDLESS OF THEIR FINANCIAL SITUATION, WHILE ITS COMMUNITY-DRIVEN GOVERNANCE EMPOWERS PLAYERS TO TAKE AN ACTIVE ROLE IN SHAPING THE GAME'S FUTURE.



4. PROBLEM-SOLUTION FRAMEWORK

4.1 TOKEN SCARCITY AND AFFORDABILITY

BLOCKCHAIN GAMES OFTEN PRICE OUT NEW PLAYERS. \$CTC SOLVES THIS THROUGH FRACTIONAL TOKEN SPENDING, ALLOWING PLAYERS TO PARTICIPATE WITH SMALLER INVESTMENTS WHILE STILL GAINING ACCESS TO VALUABLE IN-GAME ASSETS.

4.2 INFLATION AND VALUE RETENTION

TOKEN INFLATION DILUTES THE VALUE OF IN-GAME CURRENCIES. \$CTC'S DYNAMIC BURN MECHANISM COUNTERACTS THIS BY REMOVING TOKENS FROM CIRCULATION DURING SPECIFIC IN-GAME EVENTS, ENSURING SCARCITY AND PRESERVING LONG-TERM VALUE.

4.3 PLAYER RETENTION AND GOVERNANCE POWER

MANY BLOCKCHAIN GAMES SUFFER FROM WHALE-DOMINATED GOVERNANCE. \$CTC USES A FACTION-BASED GOVERNANCE MODEL, WITH 111 LEGENDARY SKULLS SERVING AS MEDIATORS BETWEEN FACTIONS AND THE 10 GODS. THIS ENSURES BALANCED DECISION-MAKING AND A COMMUNITY-DRIVEN GAME ECONOMY.



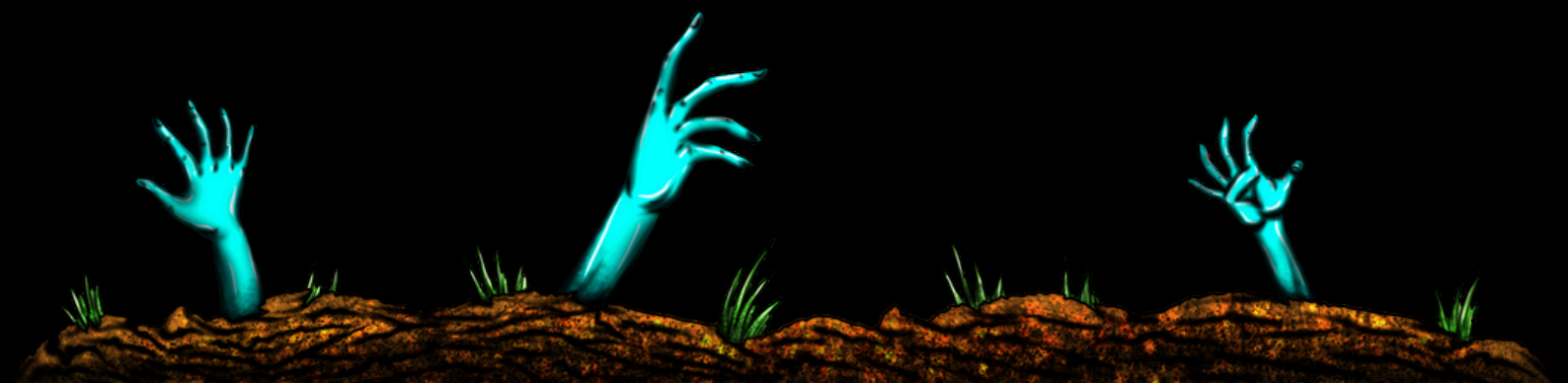


5. CRYPTS DIGITAL TRADING CARDS: EVOLVING POWER

THE 6,666 CRYPT TRADING CARDS ARE FULL-BODY SKELETON NFTS THAT EVOLVE WITH GAMEPLAY, UNLOCKING NEW ABILITIES AND EXCLUSIVE CONTENT.

EACH CARD IS LINKED TO AN NFC-ENABLED PHYSICAL COLLECTIBLE, GIVING PLAYERS A TANGIBLE ASSET TO COMPLEMENT THEIR IN-GAME PROGRESSION.

PLAYERS CAN UPGRADE THEIR CRYPT TRADING CARDS TO GAIN ACCESS TO RARE IN-GAME ITEMS, AND WHEN SOLD FOR FIAT, THE DIGITAL ASSET TRANSFORMS INTO A PHYSICAL COLLECTIBLE, WHILE THE SELLER RECEIVES A NEW SKELETON BASE CARD, ENSURING CONTINUOUS VALUE CREATION.



6. OG CRYPTS: ART-BASED BOOSTER CARDS EARNING DEADPOINTS

THE 6,666 OG CRYPTS SERVE AS ART-BASED BOOSTER CARDS WITHIN THE \$CTC UNIVERSE. TIED TO THE FOUNDER'S PERSONAL LIFE STORY, THESE NFTS EARN DEADPOINTS SIMPLY BY BEING HELD, MAKING THEM A UNIQUE AND VALUABLE ASSET WITHIN THE GAME.

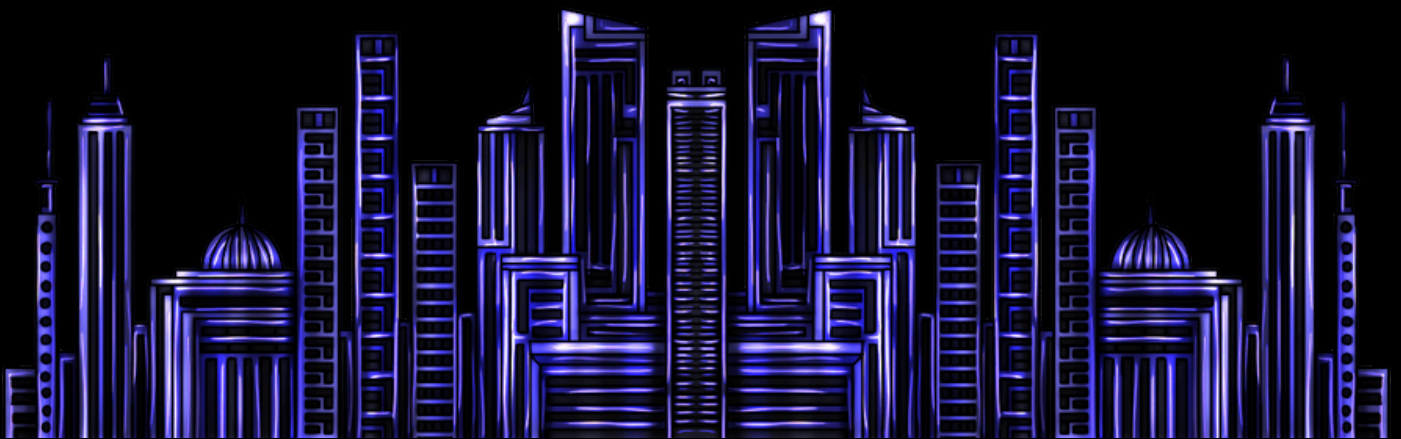

7. TOKEN ALLOCATION AND VESTING SCHEDULE

THE COMMUNITY RELIEF FUND DEDICATES 1% OF THE TOKEN SUPPLY TO SUPPORTING COMMUNITY MEMBERS IN VERIFIED EMERGENCY SITUATIONS. THE VESTING SCHEDULE ENSURES THAT TEAM TOKENS ARE LOCKED FOR 8 MONTHS, WITH GRADUAL RELEASE OVER 20 MONTHS, ENSURING LONG-TERM COMMITMENT FROM THE TEAM AND ADVISORS.



8. TOKENOMICS

8.1 FRACTIONAL SPENDING

\$CTC'S FRACTIONAL SPENDING MODEL ENSURES THAT PLAYERS CAN ENGAGE WITH THE GAME AND ITS ECONOMY REGARDLESS OF THE SIZE OF THEIR HOLDINGS. THIS APPROACH DEMOCRATIZES ACCESS TO IN-GAME ASSETS, MAKING \$CTC ACCESSIBLE TO PLAYERS AT EVERY LEVEL.

8.2 SEASONAL REWARDS

EACH SEASON INTRODUCES EXCLUSIVE NFTs, SKINS, AND COLLECTIBLES, AVAILABLE TO THOSE WHO USE \$CTC FOR IN-GAME PURCHASES. PLAYERS BENEFIT FROM USING \$CTC INSTEAD OF FIAT, GAINING BETTER VALUE AND EXCLUSIVE ITEMS UNAVAILABLE THROUGH OTHER MEANS.

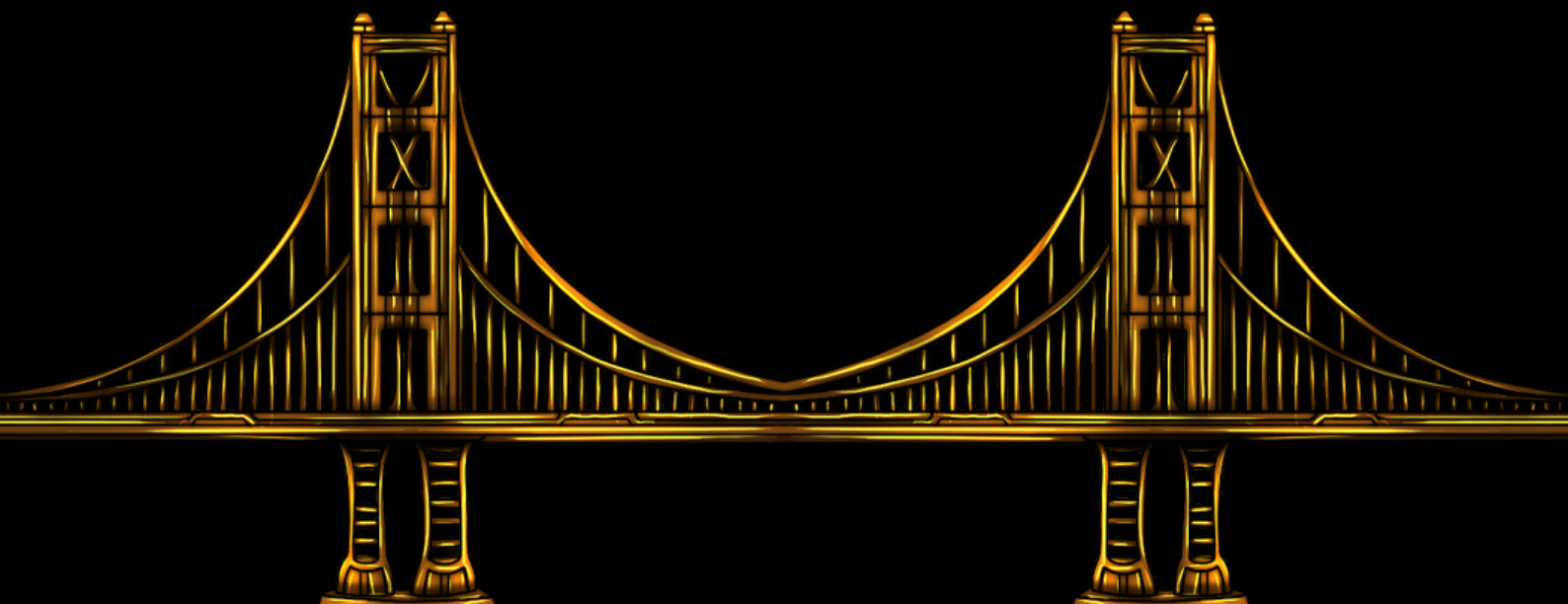
8.3 DYNAMIC BURN MECHANISM & LONG-TERM SCARCITY

TO MAINTAIN TOKEN SCARCITY AND ENSURE LONG-TERM VALUE RETENTION, \$CTC EMPLOYS A DYNAMIC BURN MECHANISM THAT REMOVES TOKENS FROM CIRCULATION DURING KEY EVENTS AND TOURNAMENTS. THIS DEFLATIONARY MODEL PRESERVES THE TOKEN'S VALUE WHILE INCENTIVIZING PLAYER PARTICIPATION.



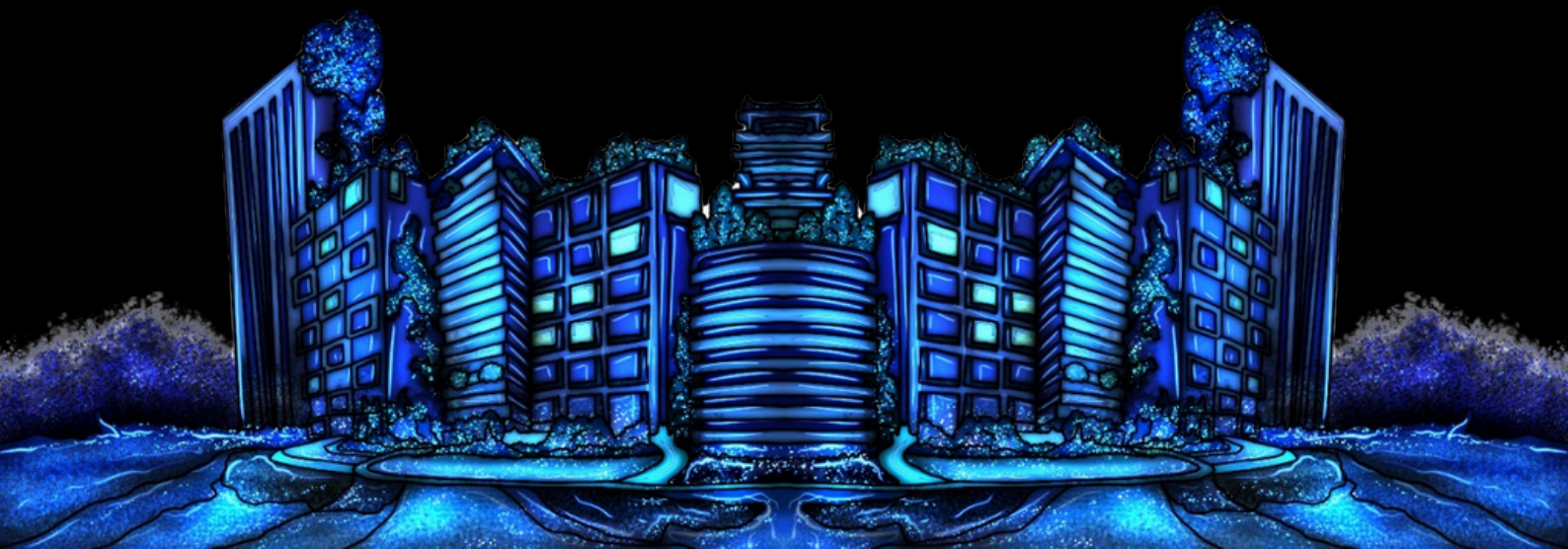
9. DEADPOINTS: BRIDGING WEB2 PLAYERS TO WEB3

DEADPOINTS ARE \$CTC'S OFF-CHAIN UTILITY TOKEN, DESIGNED TO INTRODUCE WEB2 PLAYERS TO THE BLOCKCHAIN SPACE WITHOUT REQUIRING INITIAL BLOCKCHAIN KNOWLEDGE. PLAYERS CAN EARN DEADPOINTS THROUGH GAMEPLAY, WHICH CAN LATER BE CONVERTED TO \$CTC. THIS SEAMLESS TRANSITION BETWEEN WEB2 AND WEB3 ALLOWS PLAYERS TO ENJOY THE BENEFITS OF BLOCKCHAIN GAMING WHILE GRADUALLY ADOPTING THE TECHNOLOGY.



10. GOVERNANCE MODEL: FACTIONS LEGENDARIES AND GODS

\$CTC'S GOVERNANCE STRUCTURE REVOLVES AROUND FIVE PLAYER FACTIONS, EACH OF WHICH VOTES ON KEY GAME DECISIONS. THESE DECISIONS ARE MEDIATED BY 111 LEGENDARY SKULLS, WHO BALANCE THE POWER DYNAMICS BETWEEN THE FACTIONS AND THE 10 GODS. THIS DECENTRALIZED GOVERNANCE MODEL PREVENTS WHALES FROM DOMINATING THE GAME AND ENSURES THAT THE COMMUNITY DRIVES THE DIRECTION OF THE ECOSYSTEM.



II. SECURITY: ANTI-WHALE MEASURES AND LIQUIDITY PROTECTION

\$CTC INCORPORATES ANTI-WHALE MEASURES TO PREVENT ANY SINGLE ENTITY FROM CONTROLLING TOO MUCH OF THE TOKEN SUPPLY, ENSURING A BALANCED AND FAIR GAME ECONOMY. THIS IS ACHIEVED BY LIMITING THE NUMBER OF TOKENS ANY INDIVIDUAL OR GROUP CAN HOLD, WHICH PREVENTS LARGE HOLDERS (WHALES) FROM HAVING OUTSIZED INFLUENCE ON THE MARKET OR GOVERNANCE.

ADDITIONALLY, LIQUIDITY PROTECTION MECHANISMS ARE IN PLACE TO MAINTAIN PRICE STABILITY AND PROTECT AGAINST MARKET MANIPULATION. A PORTION OF THE FUNDS RAISED IN THE PRESALE WILL BE ALLOCATED TO A LIQUIDITY POOL, ENSURING SMOOTH AND STABLE TRADING ONCE THE TOKEN IS LIVE. THIS PREVENTS SHARP PRICE FLUCTUATIONS AND ENSURES THAT PLAYERS AND INVESTORS CAN TRADE WITHOUT FACING EXTREME VOLATILITY.

THESE MECHANISMS ENSURE THAT THE \$CTC ECONOMY REMAINS SUSTAINABLE, SECURE, AND ACCESSIBLE FOR ALL PARTICIPANTS, FOSTERING A HEALTHY AND TRANSPARENT MARKET ENVIRONMENT.

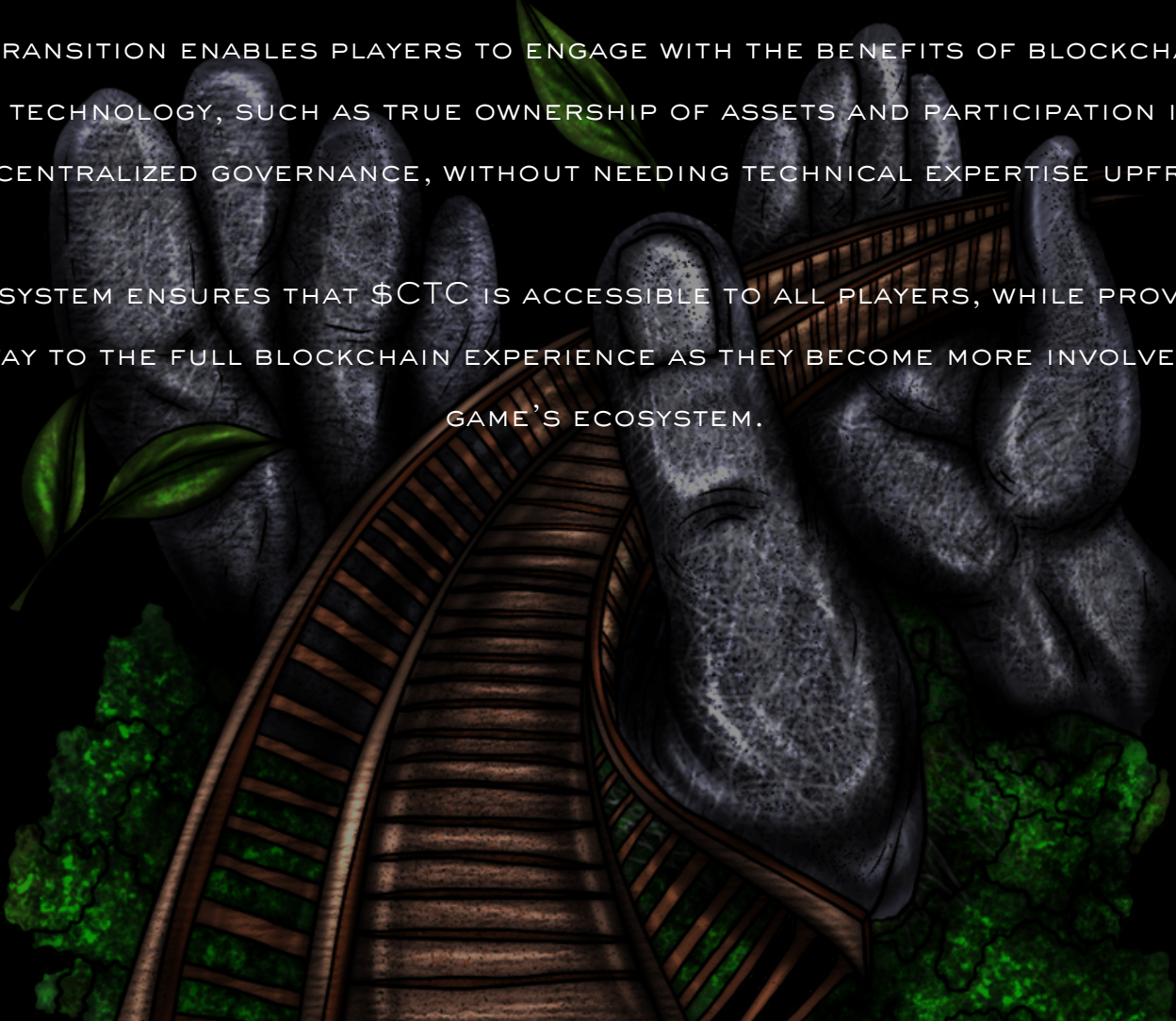


12. WEB2 ONBOARDING STRUCTURE

THESE NFTS ARE LINKED TO NFC-ENABLED PHYSICAL CARDS, WHICH OFFER EXCLUSIVE IN-GAME BENEFITS SUCH AS INCREASED DEADPOINTS EARNINGS, ACCESS TO RARE ITEMS, OR ENHANCED ABILITIES IN SPECIFIC QUESTS.

OVER TIME, PLAYERS ARE GUIDED THROUGH A SEAMLESS ONBOARDING PROCESS, TRANSITIONING FROM WEB2 TO WEB3 AS THEY PROGRESS WITHIN THE GAME. THE GAME WILL FEATURE TUTORIALS, INTERACTIVE GUIDES, AND COMMUNITY SUPPORT, MAKING THE ADOPTION OF BLOCKCHAIN FEATURES INTUITIVE AND REWARDING. THIS GRADUAL TRANSITION ENABLES PLAYERS TO ENGAGE WITH THE BENEFITS OF BLOCKCHAIN TECHNOLOGY, SUCH AS TRUE OWNERSHIP OF ASSETS AND PARTICIPATION IN DECENTRALIZED GOVERNANCE, WITHOUT NEEDING TECHNICAL EXPERTISE UPFRONT.

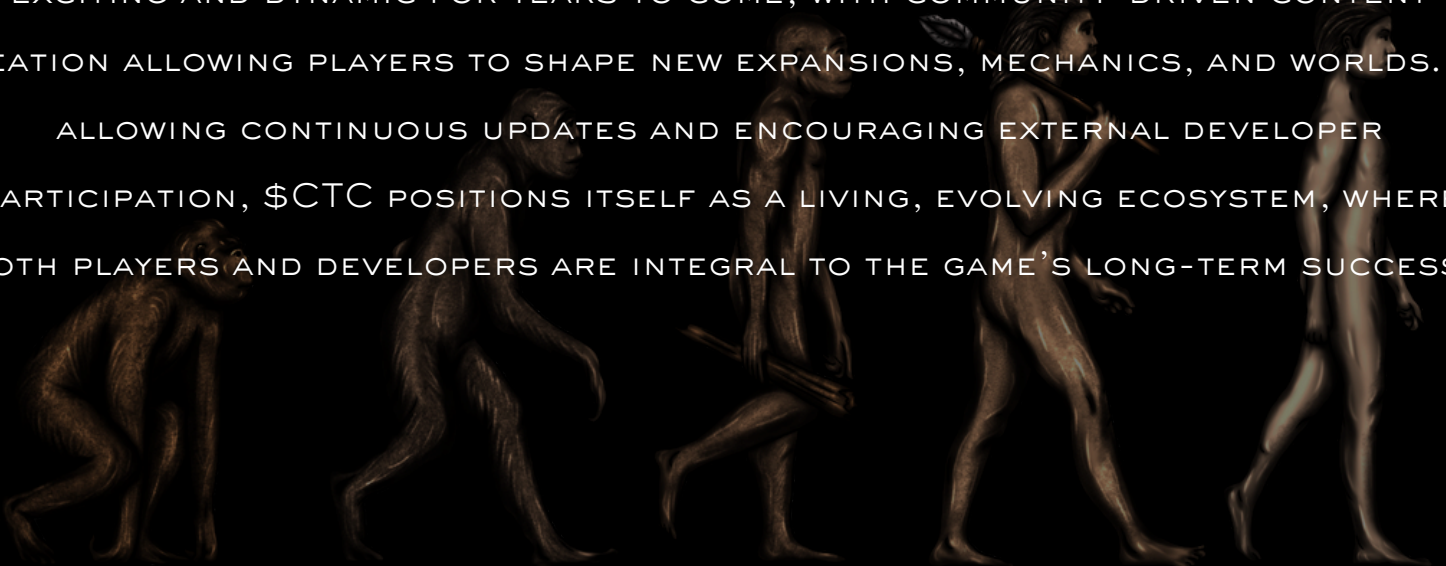


13. MODULAR GAME ENGINE AND FUTURE EXPANSION

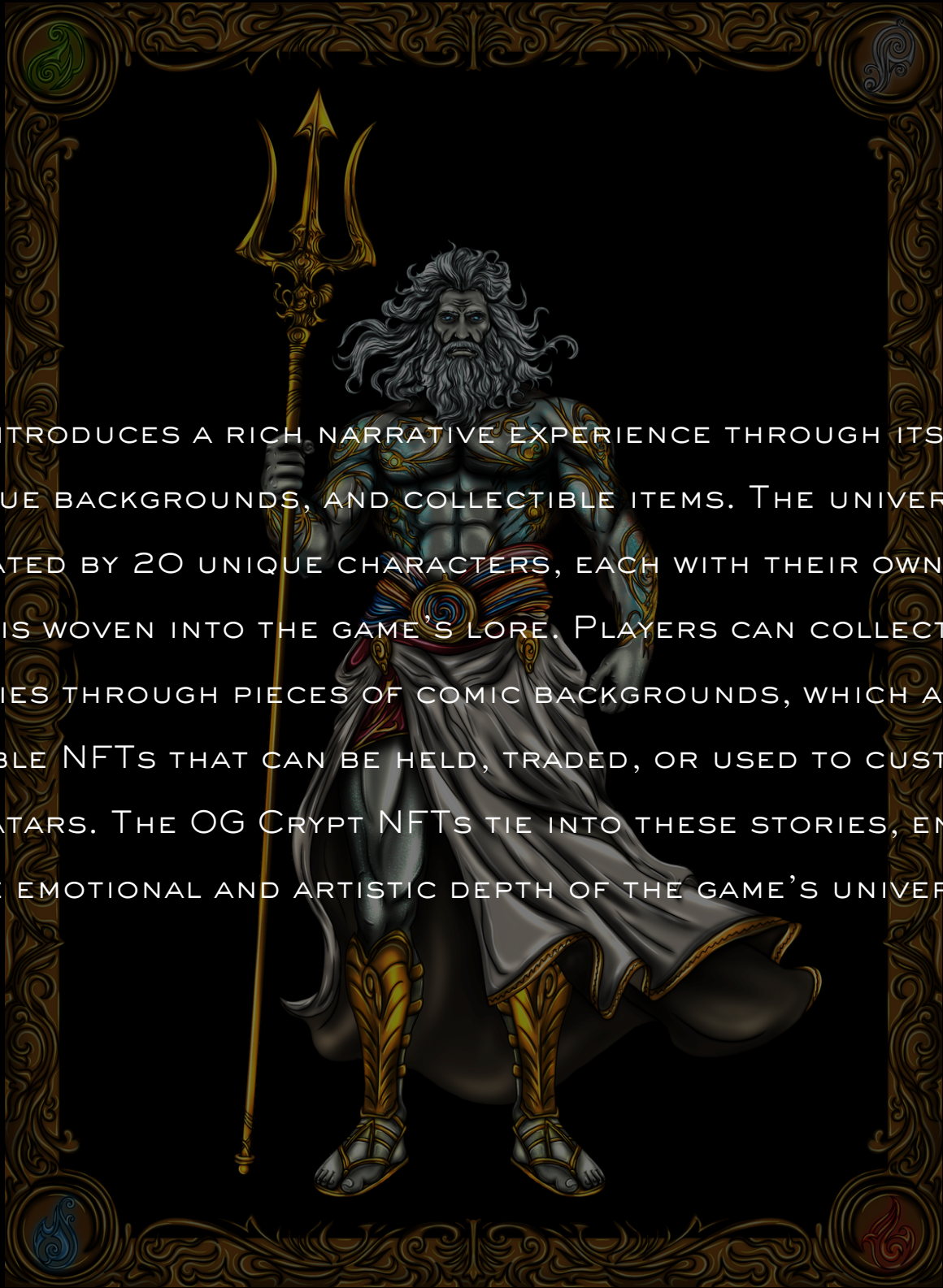

WITH ITS UNIQUE OFFERING OF TRUE OWNERSHIP, SEAMLESS WEB2 ONBOARDING, AND REAL-WORLD NFC-ENABLED COLLECTIBLES, \$CTC IS POSITIONED TO CAPTURE 0.6% OF THIS TOTAL MARKET, AIMING FOR APPROXIMATELY \$2.3 BILLION IN MARKET SHARE BY 2027.

AS THE GAMING, NFT, AND METAVERSE MARKETS EXPAND, \$CTC PRESENTS A COMPELLING OPPORTUNITY FOR INVESTORS TO TAP INTO THE FUTURE OF BLOCKCHAIN GAMING AND DIGITAL OWNERSHIP.

20. COMICS, BACKGROUNDS, AND UNIQUE COLLECTIBLES



\$CTC INTRODUCES A RICH NARRATIVE EXPERIENCE THROUGH ITS COMICS, UNIQUE BACKGROUNDS, AND COLLECTIBLE ITEMS. THE UNIVERSE IS POPULATED BY 20 UNIQUE CHARACTERS, EACH WITH THEIR OWN STORY, WHICH IS WOVEN INTO THE GAME'S LORE. PLAYERS CAN COLLECT THESE STORIES THROUGH PIECES OF COMIC BACKGROUNDS, WHICH ACT AS COLLECTIBLE NFTs THAT CAN BE HELD, TRADED, OR USED TO CUSTOMIZE IN-GAME AVATARS. THE OG CRYPT NFTs TIE INTO THESE STORIES, ENHANCING THE EMOTIONAL AND ARTISTIC DEPTH OF THE GAME'S UNIVERSE.

21. FINITE SUPPLY AND ANTI-DILUTION MECHANISM

\$CTC ENSURES LONG-TERM SCARCITY AND VALUE THROUGH ITS FINITE SUPPLY OF 6,666 OG CRYPTS AND 6,666 CRYPT TRADING CARDS. THIS LIMITED SUPPLY PREVENTS DILUTION OF THE VALUE OF NFTs, ENSURING THAT ASSETS REMAIN VALUABLE OVER TIME. TO FURTHER PROTECT AGAINST DILUTION, \$CTC EMPLOYS AN ANTI-DILUTION MECHANISM: WHEN AN NFT IS SOLD FOR FIAT, THE SELLER RECEIVES A NEW SKELETON BASE NFT, ALLOWING THEM TO CONTINUE GROWING WITHIN THE ECOSYSTEM. THIS MECHANISM KEEPS THE EXISTING SUPPLY OF RARE NFTs SCARCE WHILE OFFERING OPPORTUNITIES FOR NEW PLAYERS TO ENTER THE ECOSYSTEM.



22. RENTING AND ASSET CONTROL

PLAYERS IN \$CTC HAVE FULL CONTROL OVER THEIR NFTs, MEANING THEY CAN CHOOSE TO HOLD, SELL, OR RENT THEIR ASSETS. THIS INTRODUCES ADDITIONAL WAYS FOR PLAYERS TO GENERATE VALUE. FOR EXAMPLE, PLAYERS WHO OWN RARE, FULLY EVOLVED NFTs CAN RENT OUT THEIR ASSETS TO OTHER PLAYERS, PROVIDING ASSISTANCE IN COMPLETING SPECIFIC QUESTS OR ADVANCING WITHIN THE GAME.

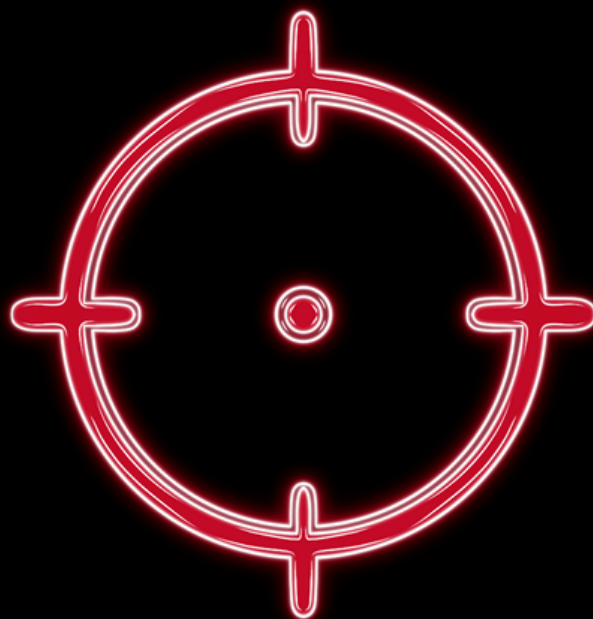
THE ABILITY TO RENT NFTs ALLOWS EVEN NEWER OR LESS FINANCIALLY ABLE PLAYERS TO ACCESS POWERFUL NFTs WITHOUT OWNING THEM OUTRIGHT, ADDING MORE FLUIDITY AND ACCESSIBILITY TO THE \$CTC ECONOMY.



23. TRUE OWNERSHIP AND EVOLUTION OF NFTs

A CORE PILLAR OF \$CTC IS TRUE OWNERSHIP. PLAYERS OWN THEIR NFTs OUTRIGHT AND HAVE THE ABILITY TO TRADE, SELL, OR UPGRADE THEM AT THEIR DISCRETION. UNLIKE TRADITIONAL GAMES WHERE ASSETS ARE LOCKED WITHIN CENTRALIZED SYSTEMS, \$CTC'S NFTs GIVE PLAYERS FULL OWNERSHIP OVER THEIR ASSETS. AS THESE NFTs EVOLVE OVER TIME THROUGH GAMEPLAY PROGRESSION, THEIR VALUE, RARITY, AND IN-GAME POWER GROW.

THE EVOLUTIONARY ASPECT OF \$CTC'S NFTs CREATES A DYNAMIC MARKET WHERE THE MOST DEDICATED AND SUCCESSFUL PLAYERS SEE THE VALUE OF THEIR ASSETS INCREASE, BOTH IN-GAME AND IN THE MARKETPLACE.



24. SOUL KEEPERS AND IN-GAME ENHANCEMENTS

IN ADDITION TO OG CRYPTS AND CRYPT TRADING CARDS, PLAYERS ARE ASSIGNED SOUL KEEPERS—SPECIAL, NON-TRANSFERABLE ANIMALS THAT PROVIDE UNIQUE IN-GAME BONUSES. PLAYERS CANNOT CHOOSE THEIR SOUL KEEPERS; INSTEAD, THEY ARE ASSIGNED BASED ON GAMEPLAY PERFORMANCE AND PROGRESSION. SOUL KEEPERS OFFER EXCLUSIVE IN-GAME ADVANTAGES AND EVOLVE ALONGSIDE THE PLAYER’S JOURNEY, ENHANCING THE PLAYER’S OVERALL POWER AND STANDING WITHIN THE GAME. THESE SPECIAL CREATURES REPRESENT A PLAYER’S DEDICATION AND OFFER A PERSONAL TOUCH TO EACH PLAYER’S IN-GAME IDENTITY.



25. FINAL NOTES FOR INVESTORS

\$CTC IS NOT JUST ANOTHER BLOCKCHAIN GAME—IT IS A FULLY-FLEDGED GAMING UNIVERSE WHERE PLAYERS ARE GIVEN TRUE OWNERSHIP OVER THEIR ASSETS. WHETHER IT'S THE EVOLVING NFTs, THE DUAL ECONOMY OF DEADPOINTS AND \$CTC, OR THE REAL-WORLD VALUE OF NFC-ENABLED COLLECTIBLES, \$CTC PROVIDES A SOLID FRAMEWORK FOR LONG-TERM VALUE GENERATION. THE INTRODUCTION OF FINITE NFT SUPPLY, ANTI-DILUTION MECHANISMS, AND COMMUNITY-DRIVEN GOVERNANCE MAKES \$CTC A STANDOUT IN THE GAMING AND BLOCKCHAIN INDUSTRIES.

FOR INVESTORS, THE FINITE SUPPLY OF BOTH OG CRYPTS AND CRYPT TRADING CARDS ENSURES THAT DEMAND WILL REMAIN STRONG OVER TIME. MOREOVER, THE INTEGRATION OF WEB2 ONBOARDING AND ACCESSIBILITY MECHANISMS, SUCH AS FRACTIONAL SPENDING, MAKES \$CTC AN APPEALING OPTION FOR A WIDE VARIETY OF PLAYERS, FROM TRADITIONAL GAMERS TO CRYPTO ENTHUSIASTS. WITH A PASSIONATE DEVELOPMENT TEAM AND A DEDICATED COMMUNITY, \$CTC IS POSITIONED FOR SUSTAINABLE GROWTH AND SCALABILITY IN THE YEARS TO COME.
